Required Documentation for Rent to Own Vehicle Agreements

What Is Rent to Own?

Our Rent-to-Own program allows you to rent and drive a vehicle. Each payment counts towards the purchase price of the car. Once all payment terms are fulfilled, the vehicle's title is transferred to you, making it a simple pathway to ownership.

How Does It Work?

Under the Rent to Own program, you will make weekly or biweekly payments as outlined in your agreement (you can choose what works better for you). At the end of the minimum rental term or upon paying the remaining balance in full, ownership of the vehicle will be legally transferred to you.

Rent to Own is a quick and easy option for owning a car, without the need to rely on credit for approval.

Required Documentation

Proof of Identity

- **Driver's License:** A valid and up-to-date driver's license to confirm your identity and legal authorization to drive.

Proof of Income – *Choose one of the following options:*

- **Pay Stubs:** Recent pay stubs covering the last 3 months to verify your income.
- **Bank Statements:** If pay stubs are unavailable or unverifiable, you will provide up to 3 months of recent bank statements to further assess financial reliability.
- **Tax Returns:** For self-employed applicants, tax returns from the past 1–2 years will serve as proof of income.

Proof of Residence

- **Utility Bill:** 1 Recent utility bill (e.g., electricity, water, cellular service) in your name to verify your residential address.

Insurance Information

- **Insurance Policy or Card:** Proof of valid insurance coverage is mandatory before taking possession of a vehicle. Liability and/or comprehensive coverage with our dealership listed as an additional insured party is required.

Authorization for Payment Methods: If using Zelle, Venmo, Cash App, or Apple Pay, setup documentation or confirmation will be requested.

Important to Note: This Rent-to-Own vehicle **cannot** be used for commercial use such as the following purposes:

- Ride-share and taxi services, and/or food delivery services such as Uber Eats/Instacart/Door Dash/Grubhub
